The Clarksville-Montgomery County Board of Education met Tuesday, February 11, 2014 in the Board room, central administration offices, 621 Gracey Avenue, Clarksville, TN. Approval of Consent Agenda

Consent Agenda items:

Dr. Worthington requested that item 4, Resolution Authorizing Construction of Oakland Elementary School, be pulled from the agenda tonight to be heard at a later date. Mr. Murphy made a motion to approve the remaining items on the Consent Agenda. Mr. Garland seconded the motion which passed unanimously.

Policy Monitoring

Dr. Worthington presented the policy monitoring report for <u>EL-5 – Financial Administration</u> noting compliance with the Executive Limitation. Mrs. Dowdy made a motion declaring full compliance with EL-5 for this reporting period. The motion, seconded by Mr. Baggett, carried 7-0.

The policy monitoring report for <u>EL-12 – Rezoning</u> was presented by Dr. Worthington. A motion was made by Ms. Murtha, second by Mr. Baggett, declaring compliance with this EL for the current reporting period. The motion passed unanimously.

Reports

Dr. Sallie Armstrong, K-8 Curriculum and Instruction Director, presented the report for Goal 3 – Align balanced assessment with Common Core implementation. Dr. Armstrong commented on the changes in the standards over the past few years from the Tennessee Diploma Project to Common Core standards. Once standards are determined, the next step is to identify how to know how well the students have learned the standards. CMCSS prepared for balanced assessment prior to Common Core and PARCC. Principals and other school leaders were trained as to what the elements of balanced assessment were. Dr. Armstrong explained that a summative assessment is an assessment at the end of the course, year, etc. that doesn't provide an opportunity to go back and do anything with. Benchmark assessments provide a way of assessing where students are during the course of teaching. Formative assessments provide an opportunity for feedback, but the student doesn't necessarily receive a grade on it.

This is a check for understanding so a teacher knows whether to go back and cover lessons again or to proceed. Dr. Armstrong provided examples of current assessments and how the results are being used. There are still many questions about how the PARCC test will be scored that have not been answered by the State at this time.

Board Member Comments

Mr. Baggett thanked all of the teachers recognized tonight for their hard work throughout the year. Ms. Murtha commented on how nice it was for the Foundation to reward the teacher candidates. Mr. Murphy noted that members of Boy Scout Troop 546 were present in the audience. Mr. Murphy also thanked the members of the Board for all they have done throughout his 20+ years on the Board. Mr. Garland thanked staff for the presentation on balanced assessments and Common Core. He stated that constituents have confusing information and need to study what is best for student education. Mr. Giles congratulated the teachers honored during the meeting. He also noted that leadership and support for the teachers has improved. Mr. Giles commented on Dr. Worthington having been recognized nationally by Education Week as one of 16 Leaders to Learn From for 2014. Mr. Giles said he appreciated the Dr. Worthington's leadership.

Minutes Clarksville-Montgomery County Board of Education Special Session March 18, 2014

The Clarksville-Montgomery County Board of Education met Thursday, March 18, 2014, in the district meeting room, central administration offices, 621 Gracey Avenue, Clarksville, TN. Board Discussion and Consideration

1. Resolution Authorizing Construction of Oakland Elementary School and Intent to Purchase This resolution had been heard for first reading at the March 6, 2014 Board study session. The resolution will be heard at the County Commission informal and formal sessions to be held April 7 and April 14, respectively. Chief Operations Officer Jim Sumrell explained that following the Commission's approval, a final agreement would be completed and site work could possibly begin in late April to early May. The building would be completed by the end of June 2015. Mr. Garland made a motion to approve the resolution, seconded by Mrs. Dowdy. The motion carried 7-0.

2. <u>Inclement Weather Make Up – Staff Recommendation</u>

Dr. Worthington noted that students had missed four additional days that could not be made up under the Board's approved Inclement Weather Make Up Plan. Staff recommended the Board allow, or "forgive", the four days to be missed without making them up at the end of the school year. Mr. Murphy made a motion that students do not need to make up the four days. The motion was seconded by Mrs. Lobdell and passed unanimously.
