Rossview Middle School Choir Director Kristina Waugh was congratulated by Dr. Gist for being selected as a 2018 CMA Music Teacher of Excellence Recipient. The CMA Foundation and Board of Directors applauded Ms. Waugh on this incredible honor and her commitment to music education.

Dr. Sean Impeartrice recognized Related Arts Consulting Teacher Angela Rouse. CMCSS was honored with the "Best Communities for Music Education" designation from the National Association of Music Merchants. Ms. Rouse answered detailed questions about funding, graduation requirements, music class participations, and community music-making programs. This is the fourth year CMCSS has received this recognition.

Reports

<u>Goal # 11 – Improve organizational efficiency through technology</u> was presented by the David Holman, Chief Communications Officer and his staff. Mr. Holman discussed current and future technology improvements for each department which included Instruction, Communications, Operations, Business Affairs, and Human Resources. Network upgrades for 1:1 middle and high schools are continuing and all 5th grade student 1:1 computers will be next in the near future.

Eric Salyer, Senior Computer Programmer, covered with the Board the improved technology work order system which has not been updated since 2009. The focus on the renewed system concentrated on the ease of using the program with minimal input as well as incorporating a knowledgebase so customers can solve certain issues without the need to enter a work order in many situations which increases efficiency for them and for the Technology department. The option to customize reports and analytics allow the department to identify trends and track key performance indicators.

Joe Williams, Senior Computer Programmer, reported on electronic document scanning and storage. CMCSS is in the process of converting records for active employees to electronic format which will increase efficiency of the storage and retrieval method. To date, over 245,000 pages of personnel records have been scanned which includes 2,036 employees. CMCSS has completed the design and training for onboarding forms for certified, classified, and substitute positions as well as benefits enrollment forms.
