## Minutes Clarksville-Montgomery County Board of Education

## **Special Session**

## **December 7, 2021**

The Clarksville-Montgomery County Board of Education met in a special session on Tuesday, December 7th, 2021, central administration offices, 621 Gracey Avenue, Clarksville, TN. The meeting was called to order at 7:13 p.m. Board members present were: Chair Herbert Nelson, Margaret Pace, Jimmie Garland, Carol Berry, Charlie Patterson, Josh Baggett and Kent Griffy. ## Resolution

Herbert Nelson, Board Chair called the meeting to order at 7:13 pm. The purpose of this special session was to vote on the Kirkwood High School Construction Cost & Contractor Recommendation Resolution, 1st Read 12/07/2021 at the regular School Board Study Session.

In April 2021, the CMCSS Board of Education approved a resolution (Resolution #21-4-7) for an architectural agreement with Lyle Cook Martin Architects/Rufus Johnson Associates Joint Venture Architects to design CMCSS' 8<sup>th</sup> High School to address student enrollment combined at all high schools at a capacity level of 91% and the middle school capacity level at 104% which will be transitioning into the high schools. CMCSS received bids for the High School in November 2021. The CMCSS Facilities Department has reviewed the bid results and recommend the bid submitted by R.G. Anderson Company be presented to the Montgomery County Commissioners for review and approval in the amount of \$91,299.748.00. Upon final approval, CMCSS recommend negotiating a contractual construction agreement with R.G. Anderson Company, Inc. in the amount of \$84,102.000.00.

Mr. Nelson called for a motion to accept the Resolution as presented. A motion was made by Mr. Josh Baggett to accept the resolution. The motion was seconded by Mr. Jimmie Garland. There was no further discussion. The motion passed 7-0.

The Special Session adjourned at 7:15 p.m.
