## MEDICATION STORAGE

Clarksville-Montgomery County School System requires medication to be kept under lock in a secure designated area in the school office or clinic. Nothing in this statement is intended to prevent children with specific conditions requiring emergency rescue with authorization from healthcare provider and parent,, or readily accessible medications such as inhalers, epi-pens, glucagon, or any diabetic supplies, or a student with pancreatic insufficiency or cystic fibrosis (after development of IHP by RN), or emergency anti-seizure medication from being readily available. Rescue medications may be carried by a student if proper authorization is provided by a parent and medical provider (HEA-F062). Rescue medications that are kept in the school clinic must be easily available to medication trained staff, but not in open view of others. Upon receiving prescription medication, it must be counted and signed by nursing or medication trained personnel and parent / guardian on the Medication Count form (HEA-F081). Medications that need to be refrigerated are kept in the refrigerator in a secure area. The school nurse will send a notice to the parents when medications expire or are discontinued (HEA-F089). If the medication is not picked up within 14 days or at the end of the last day of the school year for students, it will be properly disposed of at the end of the school day by the school nurse (HEA-A006).
