ADMINISTRATIVE POLICY

EMPLOYEE PERQUISITES

It is the policy of Clarksville-Montgomery County School System to provide perquisites to all permanent employees. The policy is based upon three key principles, listed below:

- 1. Replacement or repair of personal property damaged or destroyed as a result of an assault or vandalism incurred by employees while on duty.
- 2. Free admission to employee and one guest to school-sponsored events.
- 3. Official lifetime pass admits CMCSS retiree and guest to all activities of schools in Clarksville-Montgomery County.
- 4. Employees will have the option of enrolling in an out-of-zone school: their children for whom they are legal guardian, stepchildren who reside in the employee's household or foster children who reside in the employee's household. School based, non-school based, out of county and out of state employees refer to Employee Perquisites Procedure (HUM-P031).
