1.0 SCOPE:

- 1.1 This procedure outlines the process of the development, evaluation and revision of a district wide curriculum for use in Clarksville-Montgomery County School System (CMCSS).

3.0 APPROVAL AUTHORITY:

- 3.1 Director of Curriculum and Instruction

4.0 DEFINITIONS:

- 4.1 CMCSS: Clarksville-Montgomery County School System
- 4.2 Curriculum Project Teams: Teams of teachers that develop or revise curriculum and may be helping with the creation of various types of assessments. benchmark assessments.
- 4.3 Curriculum Hub: The website where the curriculum standards, scope and sequence, pacing guide and other resources are posted on the hub.

5.0 PROCEDURE:

- 5.1 Evaluate the current K-12 State Standards in light of student achievement data, state curriculum changes and other needs of the district (www.state.tn.us/education and TCA 49-6-1000).
- 5.2 Establish Curriculum Project Teams of representative teachers from the district to write, revise, edit and review curriculum, scope and sequence, pacing guides and benchmark assessments.
- 5.3 Curriculum Consulting Teachers will review any curriculum feedback submitted by teachers.
- 5.4 Identify curriculum/benchmark areas for revision or development and make appropriate revisions or develop new curriculum.
- 5.5 Post completed curriculum on the web to Curriculum Hub within a timely manner.
- 5.6 Communicate with teachers and administrators about new curriculum or revision to existing curriculum by email and through staff development.
- 5.7 Solicit feedback from users via survey, email or questionnaires.
