STATEMENT OF RESIDENCE

The Board of Education has established that all school-age individuals shall be assigned to a school within the area (zone) in which their parents/guardians have established their permanent home. A child must attend school in the zone where the child's parent or guardian resides. Any child who lives apart from his or her parent or guardian must still attend school in the zone in which the parent or legal guardian resides. (Guardian is defined as court appointed legal guardian). If there is a shared parenting arrangement between divorced parents, the zone is determined based on the address of the primary residential parent as indicated on the Permanent Parenting Plan Order.

There are a few exceptions to the general rule. An exception is made for a child granted an inter-district transfer in accordance with the "Special Transfer Application" procedures. There is also an exception for a child who is legally emancipated through judicial declaration, marriage, or military service, as well as for a child living in the home of an adult caregiver who has executed an affidavit under penalty of perjury. If any of these apply, additional documentation will be required.
